Rev. Rebecca spoke of how FRS is "bucking the trend" of declining membership in other congregations, and of her hopes for a transformative year.

Open Issues/Strategic Thinking

Mission Vision: Big Question

At 6:59 p.m., a Zoom conference call was initiated with Laura Park from Unity Consulting. After introductions around the table, Laura read "Fire" by Judy Brown: FRS will be "building the fire of prophetic imagination" during the Mission Vision process.

Forrest Speck described how the Mission Vision Core Team and the Parish Board will participate in the Mission Vision process. Laura Park expanded on the Parish Board role and the minister's role, and what those will look like during the course of the process. A list of facilitators is being developed by the Core Team; Parish Board members should send any suggestions to them. A board member (or 2) should be present at each of the workshops

The Parish Board then brainstormed on "what is the topic?", which will lead to development of the "Powerful Question" used in the Mission Vision process.
