A client referral includes information about the potential client, their case, and their life and circumstances. Completed requests go to a committee for review and decision.

MIRA's Citizenship Clinics are hosted throughout the state of Massachusetts, with a larger concentration of clinics in the Greater Metro Boston Area. Clinics are typically hosted on Fridays. At clinics, volunteers are usually needed for 6+ hours, typically from 9:30 am – 3:30 pm. Clinic volunteers help with registering clients, filling out U.S. Citizenship applications, and copying needed paperwork. Personalized trainings are mandatory for volunteers interested in helping directly with filling out U.S. Citizenship Applications. Brief trainings for all other volunteer stations are offered on the day of the clinic.
